### NARRATIVE

#### INITIATING INFORMATION (CASE SYNOPSIS)

On 7/31/21 Officers from the Colorado Springs Police Department (CSPD) were engaged in security for the 150<sup>th</sup> birthday celebration of the city. Multiple officers in the security detail were also responsible to respond to any civil unrest that could occur.

At approximately 1150 hours officers began making arrests in the 900 block of S. Tejon as protesters were marching in the streets causing a traffic hazard. Arrests that were made were documented under CSPD case report #21-28345.

One individual that was arrested was identified as Charles Johnson 01/23/2000 who was served and released a summons to appear for resisting/interference, unlawful to throw stones, and obstructing a passageway/roadway. Mr. Johnson was served and released on summons #31447873 at the Gold Hills Substation.

#### FURTHER INVESTIGATION

As the lead detective on this case, my responsibility is to review reports, body worn camera footage, and drone footage.

Officer D. Reyes/6185 stated he was struck by an unknown object to the right side of his head. I also read in Sergeant Wolf's report that he observed an individual "later identified as Charles Johnson 01/23/2000 throw a piece of what appeared to be wood directly at me and other officers."

I later watched drone footage from the protest, Officer Reyes was able to provide me with a time frame in which he believed he was struck with an unknown object.

I viewed drone footage and observed at approximately 1155 hours (time noted by drone footage), Officer Reyes being hit by an unknown object to the right side of his head. The object skipped off his head and landed in the roadway.

I watched Sergeant Wolf's body camera footage. He was in front of Officer Reyes and observed a black male wearing black pants red T-shirt and a red bandanna around his head carrying the drum. I observed this male in a throwing position with his right arm and throwing a wooden drumstick at a high rate of speed towards officers. In the footage I could hear an object skipping off the ground and could see what I believe to be a drumstick in the footage.

This case is being referred to the 4th Judicial District Attorney's Office for Review.

On 7/31/2021, I was assigned this case. I reviewed the reports, documented under CSPD case #21-28883.

At approximately 1150 hours officers began making arrests in the 900 block of S. Tejon as protesters were marching in the streets causing a traffic hazard. Arrests that were made were documented under CSPD case report #21-28345.

One individual that was arrested was identified as Charles Johnson 01/23/2000 who was served and released a summons to appear for resisting/interference, unlawful to throw stones, and obstructing a passageway/roadway. I viewed Officer Reyes body worn camera footage and I heard him stated "oh fuck, I got hit in the head!, Somebody just hit me in the head...Hey LT. I just got hit in the head, I don't know if it was him, but it hit my head and arm." Sergeant Wolf advised over the radio that a black male in the middle of the crowd was throwing items at officers.

As officers attempted to get this individual into custody, he would not follow commands that he was under arrest and put his hands behind his back and began resisting officers attempts to get him into custody. While the individual was being walked back by officers Sergeant Wolf states "you throw stuff at us, you get arrested." Sergeant Wolf states again "you threw shit at us, I saw that" the individual responds "yes the one time, the one-time sir.

During a search of the individuals persons, officers located a Colorado Drivers license which identified him the individual as **Charles Johnson 1/23/00**.

On 8/4/21 I interviewed Officer Reyes who told me during the event he remembered being hit on the side of his Kevlar helmet, the back of his shoulder and his upper bicep on his right side. He stated he left "stinging" and rate his pain at a 3 on a scale of 1-10 where 1 is no pain and 10 is the worst possible pain.

Using court database, I observed that Charles Johnson had posted bond on 09/04/2024 case #20CR4971. This particular is related to a similar protest where Mr. Johnson was charged with, attempted robbery, attempted theft, menacing, engaging in a riot, obstructing a highway, and disobeying a Public Safety order to disperse.

Due to Mr. Johnson already being served and released on a summons, it is our intent to cancel dismissible court summons once a filing decision is made. All charges will be referred to El Paso County District Attorney's office if accepted.

### NARRATIVE

#### **INITIAL INFORMATION:**

On 07/31/2021 I Ofc. Schnur / 5726 was assigned to a four man team to monitor activities and provide security for the 150<sup>th</sup> Anniversary Celebration in the Downtown Area of Colorado Springs.

#### **OFFICER ACTIONS AND OBSERVATIONS:**

At approximately 1150 hours I was informed that a group of protestors were marching north on Nevada Ave in the area of Mill St. Commander Koch gave an order over the radio to take the protestors into custody as the entire group had disobeyed orders to stay out of the roadway. I responded to the area to assist other officers in contacting the group and make arrests. The group, which was marching in the northbound lanes of traffic on Nevada Ave, took an alleyway across to S. Tejon St. I responded to that area to again assist officers.

Upon arriving into the area I observed a number of officers on the ground taking a protestor into custody. I took a position between the officers on the ground and the larger group of protestors to provide security to the officers and in custody party. The participants within the crowd were agitated and hostile towards officers. After several minutes officers moved the in custody parties to Police vehicles and began breaking contact with the protestors.

I began returning to my vehicle when I observed a drumstick in the northbound lanes of Tejon St. near my vehicle. I collected the drumstick. I recognized that the group of protestors had numerous wooden blunt objects to include drumsticks. I heard officers state that one officer had been struck with a wooden object.

Before returning to the vehicle, I heard loud screaming and turned to see numerous officers and protestors on the ground. I ran to their location and again took a position between the officers making arrests on the ground and the protestors. After several moments officers took several additional parties into custody and we broke contact with the crowd. I returned to my vehicle and left the area.

I Detective Granillo/3876 was assigned this case as assignment to the Gold Hill Property Division. I reviewed all case reports and supplements for this report as well as all evidence assigned to this case.

#### DETECTIVE STATEMENT

Date: 7/31/21

Time: 1000 hours

I was assigned as part of the arrest/processing team for any civil unrest that was to occur during the 150<sup>th</sup> Celebration. Prior to the celebration I had been to multiple briefings in preparation for any possible civil unrest during the celebration. I had observed information that a planned protest was to occur involving the "Chinook Center" about affordable housing. This information included that the possible organizer of this protest was an individual identified as Shaun Walls 2/11/1980. Shaun had been identified by law enforcement is being involved in multiple other protests around the city over the past two years.

At approximately 1150 hours, I heard over the radio that multiple parties had been arrested by officers in the field. I received information from these officers that they arrested Shaun Walls 02/11/1980. Officers were trying to arrest Shaun for obstructing the roadway, and in so doing he resisted. Please see other officers' supplements regarding the resisting and transporting to the Gold Hill substation.

While at the Gold Hill substation Shaun refused medical attention and was served a summons to appear for resisting/interfering with public official, obstructing a roadway, and conspiracy, reference number #3144661.

After the event I was given information that Officer Reyes/6185 had been struck with an unknown object to the side of his head. He did not sustain any serious bodily injury due to wearing a Kevlar helmet which absorbed most of the blow.

#### CASE REVIEW (21-29044)

Time: 1600 hours

As party of my investigation I began reviewing Body Worn Camera (BWC), drone footage, and officer reports. I observed in Officer Spicuglia/4925 report that an unknown female had thrown a bicycle in front of an officer to prevent him from getting to other officers who were making an arrest. I was able to view BWC footage from Officer Spicuglia/4925 and observed an unknown white female wearing a light blue/turquoise colored helmet, yellow colored lensed sunglasses, and a red T-shirt purposefully throwing her bike in front of Officer Spicuglia. observed on drone footage that Officer Spicuglia had to dramatically move to one side to prevent himself from tripping over the bike. Officer Spicuglia wrote in his supplement "As I was sprinting, a white female holding a bicycle through it in front of me in an attempt to trip me."

I was able to snap a photograph of this female and had the photograph disseminated through the department to identify her. This case was later given to detective with the Strategic Information Center (STIC) for further follow up. This case is documented under CSPD Case# 21-29044.

#### **CASE REVIEW (21-28883)**

As I continued viewing surveillance from the protest Officer Reyes was able to provide me with a time frame in which he believed he was struck with an unknown object to the side of the head. I viewed drone footage and observed at approximately 1155 hours (time noted by drone footage), Officer Reyes being hit by an unknown object to the right side of his head. The object skipped off his head and landed in the roadway.

I watched Sergeant Wolf's body camera footage who was in front of Officer Reyes and observed a black male wearing black pants red T-shirt and a red bandanna around his head carrying the drum. I observed this male in a throwing position with his right arm and throwing a drumstick in a high rate of speed towards officers. In the footage I could hear an object skipping off the ground and could see what I believe to be a drumstick in the footage.

I viewed Officer Reyes body worn camera footage and I heard him stated "oh fuck, I got hit in the head!, Somebody just hit me in the head...Hey LT. I just got hit in the head, I don't know if it was him, but it hit my head and arm." Sergeant Wolf advised over the radio that a black male in the middle of the crowd was throwing items at officers.

#### **OFFICER INTERVIEW**

Date: 8/4/21

Time: 1430

The following was a recorded interview conducted at the Gold Hill substation in an interview room. The following is not a verbatim account of the interview and merely a summary of relevant information. A copy of the interview was placed into Digital Image Management System (DIMS) under the above case report number.

I spoke with Officer D. Reyes who is assigned as part of the Homeless Outreach Team (HOT) stationed out of the Gold Hill Division. On 7/31/21 he explained he was assigned as part of a response team for an anticipated protest that was to occur during the 150<sup>th</sup> City Celebration.

Officer Reyes stated he was sent to his first call around 1040 hours on 7/31/21, where he was asked to go to a staging area near Fountain and Cascade by Lieutenant Chacon. Officer Reyes stated that this was done because information had been gathered that protesters would begin marching from Dorchester Park north on S. Tejon St. towards the 150<sup>th</sup> celebration area. He told me that he had not seen any protesters prior to the reported

incident.

Officer Reyes explained that upon his arrival at Fountain Blvd and Cascade Ave., Lieutenant (Lt.) Chacon told officers to now move to the area of Fountain Blvd and South Tejon St due to multiple protesters now being in the roadway/obstructing the roadway on S. Tejon St. He said that Lt. told him and other members of HOT to begin forming a line across S. Tejon due to the protesters blocking both lanes of northbound traffic.

He stated that he was inside a fully marked police Dodge Durango with his emergency lights activated with his partner identified as Officer Klos/5411 who was operating the vehicle. He was also assigned as a 40mm non-lethal munitions operator. He explained he was to be used as an extra resource if needed and to cover officers that were conducting arrests.

When he exited his vehicle to the intersection of Fountain Boulevard and South Tejon Street he began forming a line with other officers. He could hear Lt. Chacon giving 2 verbal warnings to the protesters, stating they needed to exit the roadway and march on the sidewalk. He stated that the protesters did not react to these warnings and made a right-hand turn to go eastbound on Mill Street.

Officer Reyes explained that once Lt. Chacon observed the protesters going down Mill Street, he ordered all units to move to the area of Fountain Boulevard and South Nevada. He explained that Lt. Chacon has also aired over the radio that he had given two verbal warnings.

When he arrived at Fountain Blvd. and S. Nevada himself and other officers again began forming a line. He observed the protesters marching Northbound on N. Nevada and observed a black male at the head of the march wearing camo colored pants, a red T-Shirt, carrying a wooden walking stick, and was very animated. He explained that this male was making multiple gestures at officers. He explained that these gestures were this male grabbing his crotch area and gestures with his hands towards officers. He could not tell what this male was saying but he knew he was yelling at officers and he could not describe the gestures.

The protesters then cut down an alleyway in front of a dealership. Officer Reyes stated that Lieutenant Chacon then moves officers back to South Tejon Street. He also remembered Lieutenant Chacon advising officers to arrest Shaun Walls, and that he is wearing camo shorts. Officer Reyes explained that he had never seen Shaun walls prior to this incident and that the description was provided by Lieutenant Chacon.

Officer Reyes explained that when officers get to South Tejon St. Lieutenant Chacon wanted Shaun walls arrested. He thought officers would be forming a line again and wait for the protesters to march to march to them. But he observed an unmarked police vehicle go around him, park, and an arrest team from the Tactical Enforcement Unit (TEU) exits the vehicle and enters the crowd to make an arrest on Shaun Walls. Officer Reyes explains he immediately exits his vehicle and runs to assist these officers in the arrest. He explained he walked into the crowd with his 40mm with the safety on and at the low ready position to cover officers. He observes four officers struggling to get Shaun Walls into custody. During the struggle Shaun Walls is able to get his own backpack off. Officer Reyes explains that he tells these officers he has a 40 mm in case they need it. Officer Reyes demonstrates that while he is telling these officers he feels a pressure to the back-right side of his helmet. He explains that almost simultaneously he feels a pressure on the back of his shoulder, the back of his right bicep and

states "it felt like someone clunked me on the back of the head." Officer Reyes described the pain as believing somebody was behind him and struck him with a stick. When he turned around, he observes that a TEU officer has somebody already in custody. He explained that he was standing near the curb line and observed a stick on the sidewalk and a wooden drumstick in the street. Officer Reyes believe that he might've been struck with the walking stick that he saw but could not be positive. I asked if he had observed who might have thrown anything at him. He replied that he did not because he was concentrated on covering the officers who were arresting Shaun Walls.

I asked Officer Reyes if anyone told him they saw him get hit. He stated that Officer Sweening had observed what she thought was a rock bounce off him. He also heard that Sergeant Wolf had observed a black male in the crowd throwing wooden projectiles at officers. But he never observed this individual.

Officer Reyes described him having a "stinging" pain to his shoulder and bicep and felt the pressure from his helmet being "definitely" hit. He said the helmet did its job to protect him. He also stated that he would later have some soreness and tingling in his arm after the reported incident.

I asked him on a scale of 1 to 10 where one is the least pain possible, and 10 is the worst pain possible what he experienced. He stated that on this scale he had a pain level of 3. He explained that he did not seek any medical attention but advised Lieutenant Chacon of the incident and was able to continue his duties. He also did not see any bruising or other injuries in the days after the reported incident and still had full use of his right arm.

Officer Reyes stated that he was wearing a French blue colored vest carrier with his bullet resistant vest underneath and a metal CSPD badge. He was also wearing a standard issued shield 616 Kevlar helmet, a set of personal glasses, standard issued tactical pants.

I completed my interview with Officer Reyes and provided him with the victims' rights pamphlet. I also contacted the victim's advocacy unit and provided them with Officer Reyes's information for further follow-up.

### DETECTIVE STATEMENT

I received information through the chain of command about an individual who had contacted the media about being assaulted by officers. The article appears to be issued on the Gazette on 8/2/21 and was updates August 3<sup>rd</sup>, written by Evan Ochsner. The article appeared to have interviewed a subject who was identified in the article as "Alex Archuleta." In one portion of the article is stated "Johnson was calmly talking with a police officer when officers approached him and yelled that he was under arrest, Archuleta said. Startled, Archuleta grabbed Johnson and wrapped his arms around him. "I was just scared, to be honest," Archuleta said, adding that he wasn't trying to interfere with any arrests and was reacting instinctually, out of fear." Accompanying this article was a photograph of the individual with what appeared to be a bruise below his right eye.

I began viewing Body Worn Camera (BWC) from officers on scene to see if I could locate the incident. I observed on Sgt. Wolf's BWC, when he was arresting Charles Johnson an individual that appeared to obstruct Sergeant Wolf for making the arrest. This individual appeared to be the same one that I observed in the article. I then viewed Officer Sheldon's BWC observed this same individual wearing sunglasses. Officer Sheldon tells this individual the backup after observing him attempting to place his arms around Johnson to prevent Sgt. Wolf from making the arrest. Officer Sheldon is able to remove him and shoved him back to prevent this. As the individual sunglasses, come off his face. Officer Sheldon pushes the individual away from the situation and even picks up the individual sunglasses and provide them back to them. ### NARRATIVE

#### INITIATING INFORMATION

On Tuesday, August 24, 2021 Sgt. Carlos Sandoval 1253, who is currently assigned to the Colorado Springs Police Department Downtown Area Response Team assisted Municipal Court officers with a potential crowd management and arrest control situation. Officers learned that Charles Johnson, DOB 01-23-2000, had an amendment to his case. Sgt. Sandoval learned that Mr. Johnson had a warrant issued for him regarding the same incident that occurred during protest where he was initially served with a city summons. The warrant was for 3<sup>rd</sup> assault and other charges. Sgt. Sandoval also learned that Mr. Johnson would be taken into custody and transported to the El Paso County Criminal Justice Center where he would be booked into for this warrant.

#### SERGEANT STATEMENT

Sgt. Sandoval had his DART officers respond to Municipal Court at 1300 hrs. Mr. Johnson's court appearance was scheduled at Municipal Court for 1330 hrs. Officers learned that there may be several other people accompanying Mr. Johnson to support him during his court appearance. Officers prepared in case Mr. Johnson supporters would cause a disturbance once he was taken into custody. Sgt. Sandoval along with Officers Winn and Daly stood outside municipal Courthouse waiting for the arrival of Mr. Johnson. Sgt. Sandoval had other officers posted inside so it was not an intimidating appearance. Prior to Mr. Johnson's arrival a female who was later identified to be the attorney for Mr. Johnson asked officers if they were there for the protesters. Once Ms. Blackwell identified herself as the attorney for Mr. Johnson, Sgt. Sandoval directed her to contact Lt. Chacon inside the courthouse. Officers observed Mr. Johnson approach the courthouse from the east. Sgt. Sandoval approached Mr. Johnson and informed him of his current arrest warrant. His attorney Mrs. Blackwell also approached and told him to be cooperative. Mr. Johnson was cooperative, turned around and placed his hands behind his back. Sgt. Sandoval placed handcuffs on him and attempted to give his property to the people that accompanied him. He wished to keep his property and continued to be cooperative throughout the contact. Mr. Johnson's friends initially became animated but eventually calmed down and there were no issues.

Sgt. Sandoval escorted Mr. Johnson to an awaiting police car where he was put into the backseat of a police cruiser. This cruiser did not have a separate cage system. Sgt. Sandoval had Ofc. Dawson retrieve his car. Sgt. Sandoval directed Officers C. Johnson and Gilmore to transfer Mr. Johnson into Ofc. Dawson's car that had a separate cage system. Ofc. Dawson later transported Mr. Johnson to CJC where he was booked into on his arrest warrant. For additional information please refer to Ofc. Dawson's supplement. Nothing further at this time.
